Exhibitors' Notice

- ALL DOGS RUN AT OWNERS RISK SOLE RISK. The event hosting club and facility, its agents, members, representatives, volunteers, etc. assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators.
- Dogs must be on a lead or crated unless running. There is a \$5.00 fine for each loose dog on the field. If a person has a dog get loose twice, you will be excused from the field, your dog will not be allowed to run, and you are not to return for the rest of the weekend of runs. No refund will be issued.
- An electric battery-operated timer will be used with stopwatch back up per AKC rules.
- An electric continuous loop with plastic bag lures will be used.
- The field is flat to the catch area, the field and catch area are completely fenced
- Every dog will be inspected before every run. Any dog that is injured, lame or in season-bitches will be excused and their entry refunded.
- There are NO refunds for absent dogs.
- Dogs may run with or without a collar. Only acceptable collars are allowed. If you are not sure we will have a rule book available. Rule books are also available for Sale. \$15 ea.
- The trial will use concurrent tests with block scheduling. There will be 15 dogs for each 1-hour time block. Each of the 15 dogs will run their 1st run and as soon as the 1st block is finished the same dogs will run their 2nd test at that point, they are through for the day.
- Dogs should be warmed up and cooled down after running.
- Everyone and their dogs should stay at least 20 feet away from the track so as not to distract the dogs from running.
- Please respect the roped off areas. Please pick up after your dogs.
- Please bring chairs and shade. There are limited trees, picnic tables and shade. Pop-ups are allowed.
- The hosting club and facility are not responsible for lost or damaged items left on site.
All exhibitors should have read and understood the regulations for Fast cat. The latest Rules will be available to read and purchase at the secretary's desk.
- Partial entries fees will be refunded if the event cannot be started or completed for reasons of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.
