# Committee Reports & Special Report

**AMCA Legislative Committee** Sue Maranto-Carnall

A committee of Stamford, Connecticut's Board of Representatives is currently considering changes to the city's ordinance which deals with "Dogs and Other Animals". One of the changes includes the use of the term "guardian". The AKC opposes portions of the ordinance as currently written along with the American Veterinary Medical Association and advocates for the term "owner". The term "guardian" may reduce the legal status and value of dogs as property, limit the legal responsibility of those keeping animals, and restrict the rights of owners, veterinarians, and government agencies to protect and care for dogs. It may also subject them to frivolous and expensive litigation. Another huge concern by the AKC is the urging that "all pets be neutered at the earliest age allowed". A growing amount

I've gotten no news though from anyone, and I know people have been doing a lot with their dogs because I see it all over Facebook. Or, even at trials that I'm at. So, write! Brag! It doesn't just have to be new titles, unless we start getting a ton of people writing, which I don't see happening. So please share your news.

Before I get to the 2014 Performance Awards, I have to share that Karina Burger had to resign from her position as Obedience chair on the Performance Awards committee. I'd take up way too much space describing how much of a help she has been to me and how much I'll miss having her on the committee, so I'll just say THANK YOU for everything. Replacing Karina is Peggy Anderson, and I'm very excited to have her on board! Peggy already has helped me fix several issues and I'm really looking forward to working together.

Now, the fun stuff: Elsewhere in the newsletter are the 2014 Performance Stats. If you see errors in the points that were awarded (or need an explanation of how they were calculated) please email me ASAP. We're giving people 30 days to contact us with errors, so the awards will be printed and mailed in early September. At least, the Top 10 Awards will be mailed in September. I'm having a bit of a hard time tracking down the person who has the new titles earned in 2014 document so I haven't been able to put together the Awards of Merit yet, but those will be completed as soon as I get the report.

Finally, the 2014 Awards!

These malamutes and their handlers deserve all the praise in the world for achieving what they have. The handlers

of scientific research demonstrates that juvenile sterilization may prove ultimately harmful to animals. Another section of the ordinance creates breeding permits. In other places where breeding permits have been required has been problematic for hobbyist breeders. Such permits penalize law-abiding citizens while creating an incentive for others to avoid licensing, vaccination, and regular veterinary care ultimately creating a public health hazard. These permits also regulate how many breeding females a breeder may own and forces sterilization of the other dogs in that kennel along with facility requirements that become expensive when meeting the standards set by the new laws.

On the AKC web site, there are concerns with proposed legislation in New York, North Carolina, Nevada, Pennsylvania, and Oregon.

deserve admiration just for attempting performance events with their malamutes, let alone achieving a title in one. Believe me, these titles are a real challenge and each one took a lot of time and hard work. Please congratulate all of these amazing dogs and handlers!

First, we'll review the rules for the AMCA obedience awards. The Black Hawk Memorial Award goes to the malamute of either sex whose average of the three qualifying scores is the highest for that year. The Flaming Flirt Memorial Award goes to the dog of the opposite sex to the Black Hawk Award winner whose average of the three qualifying scores is the highest for his/her sex. If a dog were to NQ at a trial between the first and second leg or between the second and third qualifying leg, the average of the three qualifying scores would not be affected. If a dog were to achieve extra legs toward a title, only the first three scores are counted. The owner/handler must have been a member of AMCA at the time of earning the third leg.

Traditionally, the Black Hawk and Flaming Flirt awards are reserved for Novice dogs, whereas the Oonanik Memorial Award goes to that dog earning any of the advanced titles with the highest average of the three qualifying scores. Should a dog be awarded a UDX, the average of the 10 combined qualifying scores would be considered.

# Slow Introductions

By Mary Swinyer

My favorite way to bring new dogs into the home is with 'slow introductions'. Many people like to introduce dogs on neutral turf. While this may be a good idea for dogs with territorial aggression, I personally have never actually done it with my own dogs. Puppies are easier to add to an existing pack in some ways, yet may be trickier in others, especially if you have a dog that is not comfortable or cannot be trusted with puppies. Normally when I bring a puppy home, I put it in an exercise pen or metal crate in the living room and allow my dogs into the house one at a time.



Depending on the individuals involved, I might bring them in in age order or size order or based on temperament. If everyone is comfortable with one another, I start integrating the pup into the pack right away. This does not mean I allow the pup to harass my adult dogs, nor do I allow my adult dogs to over-correct a puppy. Since my dogs are primarily house dogs, it's my job to set rules and manage interactions. Of course, when I am lucky enough to have a very stable, calm adult who instinctively knows how to \*fairly\* correct a pup without traumatizing it, I allow and support that. My puppies spend plenty of

time separated from the rest of the pack for a variety of reasons. I expect all my dogs to be comfortable together in any combination or alone. I want them more bonded with me than one another, wanting to be the one who accompanies me to classes, trials, etc., but accepting of being left at home.

If I am bringing an adult dog into my home, I do not allow my other dogs to choose it. After all, I am the one who wants a dog, has thumbs and the paycheck. While many people are anxious to get dogs together, my primary goal is good long term relationships! If that takes me a few months of extra work, I'm okay with that. Many think if dogs are okay upon greeting that they will be fine together. The reality is tensions can increase and problems can arise days, weeks, even months later if dogs are forced to interact or allowed to squabble. I am \*not\* a proponent of letting dogs "work it out."

Slow Introductions means I want to keep both/all dogs within their comfort zones. I want to allow them to practice living together without the need for interaction. I use exercise pens, crates, baby gates, etc. to give each their own safe space, while still allowing them to see, smell and hear one another.



At some point the other dog becomes just part of the scenery and I start allowing them limited supervised time together. If either dog is uncomfortable (fearful, aggressive, etc.), I want to find ways for it to associate the presence of the other dog(s) with \*good\* things. I might feed them or give them special edible chews in view of one another. When working with/training one, I might keep the other in view and either give him/her a chew or toss treats. Parallel walking is a great way to decrease tensions.

It is important to remember that puppies grow up and become adolescents. The time from around seven months to two years can be especially challenging, with 18 months being the most common time I see for dog to dog relationship to change. I've had to carefully monitor my terrier's relationship with a couple other bitches I've had. During her own adolescence she had to learn she was not allowed to control my older Border Collie going in/out the door. I did this first by leashing her to prevent the

behavior, then practicing, conditioning and eventually rewarding her for ignoring Flash, allowing her to move through the doorway while Scandal was not leashed. During one part of the Scandal/Flash relationship issues, I used a pliable vinyl basket muzzle to ensure safety while working on positive relationships.

Each of my young Malamutes reached a point where they challenged Scandal. This could not be allowed. Besides the fact that my Number One rule is No Fighting, Scandal weighs in at 14 lbs. Now you need to understand that I never leave Scandal loose with any other dogs when I am not home; it is simply not worth the risk. And though she is the smallest, she is also the one with the biggest attitude and would not back off from a fight. But my dogs are loose together when I'm home, and so the teenaged mals do learn they may not aggress toward the Queen Bitch!! One of the strategies I use is to have both dogs do down stays together. Scandal is the reason my second and third malamutes were males. Thankfully, Comet (Mal #4 and a bitch) is four plus years old and Scandal who is 14+ years old, seem to have come to terms with a mutual respect or perhaps it's just their respect for me/our relationship.

I've only had one incidence of a dog not liking puppies and that was challenging to live with for a few months. We had to have \*double\* barriers to begin with. I did lots of rewarding calm behavior, rewarding ignoring the puppy, rewarding looking at the puppy, rewarding moving away from the puppy. Eventually we were able to drop our level of security to a single barrier, and when age appropriate for the puppy to walk in the neighborhood, we started taking pup and adult on parallel walks.



### **Parallel Walks**

Over time they started to lie by one another with just a normal fence between them, and by the time the pup reached five months, the dog was able to recognize her as the same species instead of a scary alien to be killed. Play time was kept very short and very carefully monitored until it was obvious the dog was relaxed and comfortable. They are best buds today!!

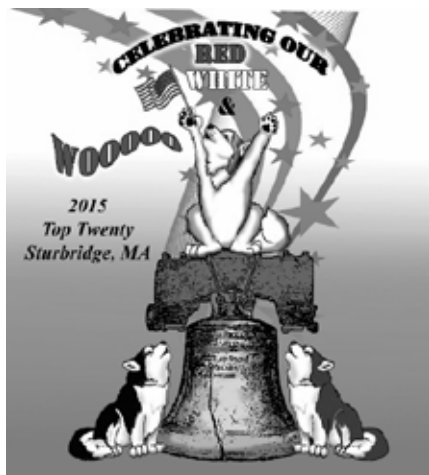

# TOP 20 RULES

## Alaskan Malamute Club of America

*As modified per annual meeting vote November 2014, Effective for 2015 Event*

This event offers all that attend a chance to view the “cream of the crop.” Each entrant is evaluated individually in his/her relationship to the breed standard, using a scale of points. This procedure is not available at any AKC point show and allows each person in the audience to judge the entrants, using a score sheet at the same time the judges are scoring them.

The entrants are observed from a positive approach; they are not fault judged. The event promotes discussion of the standard, where ideas and views are exchanged. This event will be held prior to the Best of Breed judging of the National Specialty, as knowledge of the results of the National Specialty competition could influence the outcome of the Top 20 judging.

### Statistics and Eligibility

The 20 Alaskan Malamutes eligible for the Top 20 Event are based on the following:

1. Top 20 Points are earned at any AKC All Breed Show, Limited Breed Show, or any Independent Specialty Show where AKC points are awarded. The term “dog” herein shall refer to either dogs or bitches with no preference given. One point is awarded for each Alaskan Malamute defeated by going Best of Breed or Best of Opposite Sex to the Best of Breed. Tabulation of points will be compiled from the results published by AKC for the period commencing May 1 and continuing thru April 30th of each year. Corrections published by AKC after April 30th will not be considered.
2. Standings will be compiled monthly and each primary owner of record, who has a dog in the Top 20, will receive e-mail notification showing the standings through that month. A list of the Top 20 dogs will be announced in the AMCA Newsletter. Any discrepancies in the final standings must be reported to the Top 20 Statistician before May 31<sup>st</sup>. All past winners who qualify for the current Top 20 are eligible to compete.
3. A dog is ineligible to compete in the Top 20 Event if ANY owner(s) of record is judging any portion of the National Specialty or Regional Specialty preceding the National Show. A dog is ineligible to compete in the Top 20 Event if any owner(s) of record is suspended from AMCA or AKC (1) as of April 30<sup>th</sup>, the end of the qualifying year and/or (2) as of the date of the Top 20 Event. Refunds of entry fees will not be made if ANY owner of record is suspended after the entry fee has been paid.

### Trophies and Rosettes

Each dog entered in the Top 20 Event will receive a rosette, being a minimum of two (2) feet in length. Each rosette shall have the entrant's name, the date and place of the event and the name “AMCA Top 20 Event” imprinted. The AMCA Logo will be imprinted on the rosette button. The rosette may be any color other than that of Best of Breed, Best of Opposite Sex or Winners Dog/Bitch. A trophy will be presented to the winner. Any qualifying Top 20 owner of record shall have the right to order additional rosettes at a cost to be determined annually by the Top 20 committee. The primary owner of any dog who qualifies, but for any reason chooses not to enter the competition, shall be allowed to order a rosette(s), at a cost to be determined annually by the Top 20 committee.

### Invitation to Participate and Entry Fees

1. A formal invitation to participate in the Top 20 event will be mailed to the primary owner of each Top 20 dog, based on the final standings. Included with the invitation will be instructions for entering and deadlines to adhere to.
2. The entry fee for dogs whose primary owners are AMCA members is \$125.00 per dog. The entry fee for dogs whose primary owners are not AMCA members is \$175.00 per dog. To be eligible for the member-discounted rate, the primary owner must be an AMCA member as of April 30, the last date of the qualifying period.



## Judges and Judge Selection

Upon receipt of entry fee, the primary owner will be asked to provide the names of one (1) AKC judge, one (1) Breeder judge, and one (1) Handler judge. To assist, the event chairperson will provide entrants with a list of AKC judges who reside within a 200-300 mile radius of the event and the names of any breeder judges who have indicated, to the committee, an interest in judging. A primary owner's nomination is NOT restricted to the list provided. All names submitted by the primary owner MUST conform to the criteria listed in Section A, Section B, and Section C below. The Event Chairperson will contact each name submitted to verify their qualification, confirm with them that they meet all required criteria, and, are available and willing to judge if chosen. All qualified judges names will then be given to a disinterested person, designated by the Event Chairperson, who has absolutely no connection to the event. Random draws for each category will then take place until one (1) AKC judge, one (1) breeder judge, and one (1) handler judge have been selected. The person drawing will sign a statement to the effect that he/she has no connection with the event and that the selection was completely at random. The event chairperson will then contact each of the three (3) judges chosen to verify their availability. If any judge selected is not available, or does not meet the criteria in Section A, Section B, and Section C below, another selection will be made and another statement will be signed that this is the second (or subsequent) selection.

The panel of three (3) judges selected will conduct the judging of the event the scores will be averaged to determine the winner. In case of a tie, the "Judge's First Impression" score will be used to break the tie, with highest average placement being declared the winner.

The panel of three (3) Judges will represent different categories as stated in A, B, and C below:

A. BREEDER: One (1) breeder judge will be selected by random drawing from qualified persons who meet all the requisite criteria as breeder judge and who express an interest in judging this competition. The random selection for the three judges will take place at the same time as the random selection for the two AKC judges. An established Alaskan Malamute breeder must have been breeding Alaskan Malamutes for a minimum of five (5) years and must have produced at least five (5) conformation AKC Alaskan Malamute champions as published in the AKC Awards. Breeder judges must be AMCA members in good standing. Two or more AMCA members of the same household may be nominated; however, the first name selected and approved from the member household shall result in the disqualification of other member(s) from the same household. Breeder judges must not have any connection to any dog entered in the Top 20 competition. Breeder judges must guarantee that he/she does not have any of the following connections to any dog in the Top 20 competition, by signing an informational form to determine such qualification.

1. Breeder judges cannot own or co-own the sire or dam of any dog in the competition.
2. Breeder judges cannot have bred or co-bred a bitch to any dog entered in the competition.
3. Breeder judges cannot have bred or co-bred a dog to any bitch entered in the competition.
4. Breeder judges cannot own or co-own any dog entered in the Top 20 competition.
5. Breeder judges cannot own or co-own any puppies produced by a dog/bitch in the competition.
6. Breeder judges may not share National week accommodations with the breeder, owner, co-owner or handler of any Top 20 participant.
7. Breeder judges are eligible to judge at this event once every ten (10) years and shall not be eligible to judge again until the eleventh (11<sup>th</sup>) year following their last assignment.

B. AKC: One (1) AKC judge who is approved to judge Alaskan Malamutes, have expressed an interest in judging this competition, and meet all qualification (above Section A 1-7) criteria of breeder judge listed in the section above as well as the following requisite criteria:

1. AKC judges must be approved to judge at least four (4) other breeds as set forth in the AKC Judge's Directory.
2. AKC judges are required to give his/her consent to judge at the event, prior to being placed in the random draw.
3. AKC judge's residence should be within a 200-300 mile radius of the National show site.
4. No AKC judges may judge the Top 20 Event more than once in any ten (10) year period.



5. No provisional judges shall be used for the judging of this event.
  6. Conformation judges who are under contract for future National Specialties and associated Regional Specialties shall not be eligible to judge any Top Twenty Event prior to and including the year of their assignment.
- C. HANDLER: One (1) Professional (past/retired or present): The handler judge will be selected by random drawing from qualified persons who have expressed an interest in judging this competition, and meet all qualification (above Section A 1-7) criteria of breeder judge listed in the section above as well as the following requisite criteria: :
1. Meets the criteria for membership in the Professional Handlers Association (PHA) though not necessarily a member.
  2. Must have a minimum of five (5) years handling experience.
  3. In the event a Handler judge is not obtainable, a Breeder-At-Large may be used as alternate, that shows an interest in judging this event, is a qualified licensed judge for judging Alaskan Malamutes in their country of domicile, and meet all qualification (above Section A 1-7) criteria of breeder judge listed in the section above

Each judge on the final judging panel shall be asked not to disclose it to anyone; the judges will be introduced at the Top 20 event.

### Catalogs

A catalog will be printed for this event. No advertising will be allowed in the event catalog. The catalog must include, but is not limited to, the following:

- A. The cover shall consist of the Top 20 EVENT logo, the words TOP TWENTY EVENT, the event date and city where the event is held.
- B. A list of the final Top 20 dogs in descending order and a listing of the Top 20 dogs that are participating for the current year.
- C. A two-facing page spread of each entrant in the final Top 20 standings who has paid the required fee. There will be no further charge to entrants for these pages.
  - A. The left-hand page shall have the name of the entrant, names of owner(s) and breeder(s) and a write-up about that dog, furnished by the primary owner (even-numbered page).
  - B. The right-hand page shall have a full body photo of the entrant and a four (4) generation pedigree, including the dog's date of birth (odd-numbered page).
  - C. Each dog will be issued an armband number that will correspond with the odd-numbered page of the entrant in the event catalog.
- D. A copy of the scale of points used for the competition is printed in the catalog to encourage this discussion among the audience during the event.

### Ring & Judging Procedures

**A mandatory meeting of Exhibitors/handlers** – will be held prior to the start of the competition. Only one (1) representative, per dog, shall be allowed at the mandatory meeting. An exhibitor/handler who does not check in for the mandatory meeting will automatically be given #1 spot in the competition order and will be the first dog to enter the competition. If multiple exhibitors do not attend the mandatory meeting, all absentee's numbers will be placed in a box and will be drawn to determine their competition order. The first absentee drawn will compete first, the second absentee drawn will compete second, and so forth until all absentee numbers are assigned for the competition. After absentees have been assigned their competition order, completion of the drawing will be conducted to determine the order in which the remainder of the dogs enter the ring. Drawing of those present will be by rank of dog entered, in descending order based on the Final Standings. In the event of a tie in final standings, each dog that is ranked the same will be placed in a separate box and the event chairperson will draw to determine who draws first. After the competition order has been determined, the com-

peting dogs will be divided into groups for the individual judging portion of the competition.

**Ring Set Up** – The ring will be set up with three (3) judging stations. Each station will include a table and two (2) chairs. A separate trophy table will be set up. At the commencement of the event, the judges and ring stewards will be introduced and escorted to their respective station where they will be provided with a score sheet for each individual entrant and an envelope to place their completed score sheets in.

**Ring Procedure & Judging** – The Emcee shall announce the dog in the ring as being the entrant on page number \_\_\_\_\_ (odd-numbered page) in the catalog. The Emcee shall instruct the handler as to where to position and gait his/her dog.

The entrants shall adhere to the following procedure:

- A. Each entrant shall be evaluated individually in his/her relationship to the breed standard, using a scale of points as stated in the event catalog. Points must be scored in whole points only.
- B. The entrants shall be brought in together, in the order drawn for competition, for two complete revolutions around the ring, as an initial introduction and welcome from spectators and judges and will then exit from the ring.
- C. For each group, the first entrant will complete one revolution back to the entrance gate and then walk to his/her assigned judging station. Each remaining dog in the group will do the same. When all the dogs in the group are at their assigned stations, the judges shall proceed with their examinations.
- D. Judges will individually examine and score each entrant at their station. Judge's "First Impression" score will be recorded before the actual hands-on examination takes place and will only be used in the event of a tie. Upon completion of individual examination, judges are asked to be seated at their station to indicate judging on that particular dog is complete. The Emcee will announce when it is time for entrants to move on to the next station.
- E. When all judges have completed their examination of all the dogs in the group, the judges will be moved to the diagonal to observe each dog do two individual down and backs and a 4-point stack to be completed in the center of the ring. The dog will then complete two revolutions around the ring for the judges to evaluate and return to its original station.
- F. After each dog has been moved for the judges, all of the dogs in the group will complete one revolution around the ring together, then exit. After each dog has been moved for the judges, all of the dogs will line up behind the dog closest to the ring entrance. The dogs will then complete one revolution around the ring together and then exit.
- G. When the judges have finished evaluating the first group, the next group(s) will come in following the same procedures until all entrants have been evaluated.
- H. When judging has been completed, all dogs will be called back into the ring one at a time, while their biography is being read, at which time they will be presented with their rosette and a Top 20 Catalog.

### **Score Sheets and Determination of Winner**

When Judges have completed their scoring of an entrant, they will be required to sign the score sheet and turn the score sheet into the ring steward who will check for accuracy and immediately place it in the envelope provided. No score sheets shall be tabulated by the judges or stewards. Following Best of Breed judging of the National Specialty, each score sheet shall be tabulated by a committee, consisting of the Top 20 Event Chairman, one other committee member, the Top 20 Statistician, and, one Board Member selected by the Top 20 committee. The dog with the highest score will be declared the winner. In case of a tie, **the Judge's First Impression score marked by each judge will be averaged to break the tie.**

In the event a judge is determined to be disqualified after the competition has been completed, but before the score sheets are tallied, that judge's score sheet will be discarded for each entrant and the remaining scores will be totaled to determine the winner. Because all judges have signed a contract or agreement before being eligible to judge, after the score sheets have been tallied there will be no recourse from any entrant regarding the winner.

Completed score sheets will be provided to the primary owner of each entrant in the Top 20. The scores will not be made public by anyone involved with this event. If the owner wishes to publish the dog's scores, it will be at his or her own discretion.

### **Fundraiser – People's Choice Award**

As a Top 20 fundraiser, an annual "People's Choice" award will be given. To determine the winner of this award, ballot tickets will be sold. All ballot tickets must be purchased and turned in by the conclusion of judging and prior to the dogs being called back into the ring for the reading of their biographies as stated above. Ballot tickets will be tabulated and the winner announced. The "People's Choice" winner will lead a "victory lap" around the other participants gathered in the center of the ring and will then lead all entrants around for one final lap before exiting the ring.

The Top 20 Committee retains the right to establish additional fundraiser events in any given year.

### **Cancellation of Event / Additional Fees**

At any time the entry drops below 12 entrants, the event may be cancelled for that year.

**The event committee may charge a nominal spectator admission fee of \$3.00 per person for those spectators who do not attend the Top 20 dinner gala. In any year when admission may be charged, entrants in the Top 20 event shall receive 4 complimentary tickets for admission only.**
